

GROUP SUMMER POOL RESERVATIONS

(for groups who are reserving for more than 1 session)

POLICY FOR POOL RESERVATION: Jacobs Aquatic Center (JAC) requires a deposit on ALL group reservations. The deposit is based on the estimated number of children and chaperones. The group must pre-paid a day rate to have on hand at the facility. This deposit will be held and will be applied to the entrance payment on the last reservation. If the group fails to appear on a scheduled date, the deposit will be forfeited, and any other reservations will be cancelled until a new deposit is presented. The deposit is NOT refundable. JAC also requires a 48 hour notification if the group number will exceed the booking number by more than 10 people. If notice is not given, JAC will charge full daily rate of admissions for any number exceeding the original booking reservation. Reservations are secured with cash, check or credit card.

PAYMENT IS EXPECTED ON THE DAY YOU VISIT THE AQUATIC CENTER. NO EXCEPTIONS! ABSOLUTELY NO OUTSIDE FOOD OR DRINK IS PERMITTED INTO THE AQUATIC FACILITY. THE USE OF SPRAY SUNSCREEN IS NOT PERMITTED IN THE FACILITY AND MUST BE APPLIED OFF PROPERTY. GROUPS WHO VIOLATE THIS RULE WILL BE ASKED TO LEAVE WITHOUT REFUND.

JAC is sensitive to weather conditions. We will permit re-booking for inclement weather if the party has been at the facility less than 1 hour. Any time exceeding the 1 hour period is non-refundable. Re-booking may be done before you leave the facility. JAC requires re-booking reservations to be scheduled within 3 days of the weather incident otherwise the opportunity to re-book is void. Re-booking may be for any day, but must be within our bathing load capacity.

JAC defines inclement weather as thunder storms, lightening, or heavy rain which requires the Life Guards to close the pool. Light rain or drizzle is not considered inclement weather.

Group bookings are held in three hour increments. If the group arrives late they are not permitted to stay past the booked departure time. A Full Daily Rate may be purchased for extended stays.
